Meetings last 2 - 2 ½ hours. The Board also holds a special meeting near the end of each month to discuss park matters. The meeting usually lasts 1 - 1 ½ hours.
3. Stays informed about District matters, prepares themselves well for meetings, and reviews and comments on minutes and reports.
4. Attends special events or presentations by the District.
