### HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 71



1. Comments and website inquiries from the public (3 minute limit).
2. Security report.
3. Convene in Executive Session to: (1) deliberate the deployment, or specific occasions for implementation of security personnel or devices pursuant to Section 551.076, Texas Government Code; (2) discuss purchase, exchange, lease, or value of real property pursuant to Section 551.072, Texas Government Code; and (3) consult with attorney pursuant to Section 551.071, Texas Government Code.
4. Reconvene in Open Session and authorize appropriate action.
5. Approve Minutes.
6. Review Arbitrage Rebate Report for the Series 2009 Bonds.
7. Approve Master Services Agreement with Storm Water Solutions, LP.
8. Report from Storm Water Solutions, LP regarding storm water maintenance and management, including permits, repairs, and proposals.

  - c. improvements at Bundy Lake Park and Plaza, including fencing replacement project, trail improvements, and retaining wall replacement; and
  - d. other planned capital improvements, including review capital improvement plan.
