

## NOTICE OF MEETING

1. Security report, including, if appropriate, convene in Executive Session to deliberate the deployment, or specific occasions for implementation of security personnel or devices pursuant to Section 551.076, Texas Government Code.
2. Reconvene in Open Session and authorize appropriate action.
3. Comments and website inquiries from the public (3 minute limit).

6. Report from Storm Water Solutions, LP regarding storm water maintenance and management, including permits, repairs, and proposals.

8. Development of District lakes, parks, and recreational facilities, including approve design, authorize advertisement to bid, approve proposals, review bids and award contracts, and pay estimates, change orders, substantial completion, and final acceptance for:
  - a. additional improvements to Lone Star Lake;
  - b. improvements to Mirror Lake;
  - c. improvements at Bundy Lake Park and Plaza, including trail improvements and decorative wall replacement; and
  - d. other planned capital improvements, including review capital improvement plan.
9. Operation of District facilities, including:
  - a. report on additional payment options;
  - b. Merchant agreement with Compass Bank;
  - c. Addendum to Operator Agreement; Resolution Approving Treasury Management Services and Authorizing Operator;
  - d. transition plan and schedule for new payment portal; and
